### Course Provisions

- **Green Light Driving Academy will provide a minimum of 6 hours of classroom instruction with a certified Michigan Driver Education Instructor.**
- **A driving log must be presented to verify that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent/guardian or a designated licensed adult driver 21 or older, a log was presented to the Segment 2 on or before the first classroom session. ### Course Terms

- **Parent/Guardian agrees to pay \$75 by the first day of class in the form of credit, cash, or check.**
- Students must be on time for all classroom sessions. Tardiness or failure to show up will not be tolerated and may result in a dismissal from class. Absences are not allowed. Students must attend all 6 hours of classroom instruction. If a class day is missed, the entire program will need to be rescheduled for another date and full fee will be required.
- In order to change or cancel your program dates without penalty, a 48 hour or more notice or a \$10 fee will be added to the account. If less than 24-hour advance notice is given to cancel or change a program date, the entire payment will be forfeited. Prices are subject to change.
- Students must score 70 percent or better on the Secretary of State mandatory written test
- **The Student will be allowed up to 2 retakes; a total of three attempts but not required, to pass the State Exam, which requires a score of at least 70% before being required by the State of Michigan to retake the entire Segment 2 class. Students needing to retake the class will be required to pay the full fee.**

### REFUND POLICY

- If Student fails to attend class, no refund will be given; see course terms for explanation of attendance.
- To request a program change without penalty, a 48 hour or more notice or a \$10 fee will be added to the account. If less than 24-hour advance notice is given to cancel or change a program date, the entire payment will be forfeited. Prices are subject to change.
- Emergency situations will be determined on an individual basis by Green Light Driving academy.
